SikaPlast<sup>®</sup>-178 LK is a 3rd generation polymer based high performance superplasticizer for producing soft consistency concrete.

### USES

SikaPlast®-178 LK is mainly suitable for the manufacture

of concrete for RMC plants and site batch concrete. SikaPlast®-178 LK is used for the following types of concrete:

- Bored piles
- Barrette foundations and diaphragm walls
- Ground and suspended slabs
- Columns and walls
- Bridges and cantilever
- Cement mortar and grouts

### FEATURES

SikaPlast®-178 LK combines different modes of actions.

By adsorption on the surface of the fines and keeping them apart while the hydration is in progress, Sika-Plast<sup>®</sup>-178 LK effects the following concrete properties:

- Long slump keeping and high water reduction;
- High flowability (considerably reduced placing and compacting work);
- Faster evolution of early strength development;
  Improved creep and shrinkage resistance character-
- Improved creep and snrinkage resistance characteristics;

• When used at higher dosages, SikaPlast®-178 LK can give extended working time.

SikaPlast<sup>®</sup>-178 LK contains neither chlorides nor other corrosion inducing substances and can therefore be used without any restrictions for reinforced concrete structures.

#### **TECHNICAL INFORMATION**

Concreting guidance	Concrete placing: With the use of SikaPlast®-178 LK , concrete of highest quality is being produced, however state of the art concrete technology, such as mixing, placing vibrating and curing must be respected and ap- plied. Curing: Effective measures for concrete curing must be followed.
Specific advice	SikaPlast <sup>®</sup> -178 LK is added to the gauging water prior to its addition to the dry mix or added separately to the wetted concrete mix. For optimum util- ization of the ultra-high range water reducer we recommend a minimum wet mixing time of 60 seconds. When adding the balance of the batching water to adjust concrete consistency this should be done after a minimum of 2/3 of the wet mixing time to avoid surplus water in the concrete.

#### **APPLICATION INFORMATION**

Recommended dosage	Optimum dosage of SikaPlast®-178 LK should be determined by site trials. Recommended dosage: 0.2 – 2.0% by weight of cementitious. A higher dosage might be used if agreed by client or consultant.
Compatibility	SikaPlast <sup>®</sup> -178 LK may be combined with all Sikament, Sika <sup>®</sup> Aer, Sika <sup>®</sup> Pump, Sikacrete <sup>®</sup> PP-1 products, but must be added separately to the mix and not premixed prior its addition. SikaPlast <sup>®</sup> -178 LK is compatible with all Portland cement types.
